

2019 HOMECOMING Guest Contract

All Guest Contracts Must be Turned in when Purchasing Tickets

- PLEASE PRINT LEGIBLY OR YOUR CONTRACT WILL NOT BE PROCESSED.
- Read and abide by all rules. (See back side)
- Signature of approval by an administrator from the guest's high school, ALONG WITH THE BUSINESS CARD OF THE ADMINISTRATOR SIGNING.
- Attach a CLEAR photocopy of the guest's picture ID (high school ID or driver's license for non-high school students).
- Parent signatures of DHHS student and guest (if applies.)
- DHHS student: Check the list outside of the Activities Office for any ASU debts. These debts must be paid/cleared before the contract can be accepted by Ms. Stover or Mr. Nedler.
- **Tickets must be purchased by closing (3:00pm) on Wednesday, October 2, 2019, in order to avoid a late fee.**
- **Tickets purchased Thursday and Friday, October 3 & 4, Will be assessed a \$10 LATE FEE PER TICKET. No tickets will be sold after 3:00pm on Friday, October 4, 2019.**

All signatures will be verified and any forgery will result in not being able to attend the dance.

Tickets on sale:

July 25 through August 25 (Registration Discount) \$45/\$55

August 26, through October 2: Base price of \$50/\$65.

October 3-4, 2019: Add a \$10 late fee** per ticket to the base price.

Base Pricing:

\$50 DHHS student has an ASU Card

\$65 DHHS students without ASU Card and all approved guests.

1. The 2019 Homecoming Dance will be held on Saturday, October 5, 2019 on the campus of Dana Hills High School. The dance will begin at 7:00 p.m. and end at 10:00 p.m. **NO STUDENTS WILL BE ADMITTED AFTER 8:00P.M. UNLESS PRIOR ARRANGEMENTS HAVE BEEN MADE WITH THE ACTIVITIES DIRECTOR, MR. NEDLER.** Parents will be notified if their child does not check in. If you are unable to attend, please call the Activities Office (during school hours) 949-496-6666, ext. 2200.
2. Students may not leave the dance until 9:00 p.m. Those who leave at 9:00 p.m. or after will not be readmitted. Smart casual attire is required.
3. **Students must be dressed appropriately at all times.** This is a district wide dress/grooming standard. Students that are out of compliance with these standards, on the first offense will not be allowed into any dance/activity. Students must always wear a shirt and pants or the equivalent, or a dress or skirt and shoes. On subsequent offenses parents will be contacted to bring appropriate attire or to pick up the student. Collared shirts are required for semi-formal dances, ties are required for formal dances.
These items are NOT allowed: Any items that contain offensive, illegal, violent, obscene symbols, signs, slogans, or words degrading any gender, culture, religion, ethnicity, race, or anything that may incite a negative response or conflict including reference to sex, drugs, alcohol or tobacco. Clothing or accessories considered unsafe, dangerous or a health hazard. Clothing that significantly and/or intentionally reveals undergarments. Items that obscure the face, except as a religious observance.
4. Students must be picked up within 15 minutes of the conclusion of all dances. Students be left at the venue longer than 15 minutes past the conclusion of the dance will not be allowed to attend the next formal dance.
5. **District policy states that all guests must be UNDER the age of 20 years and 11 months and middle school students may not attend.** Dana Hills students and their guests must complete the guest contract and are required to abide by all school rules and the terms of the contract. Anyone exhibiting disruptive behavior will be removed from the dance, parents will be notified, and no refunds will be given.
6. According to Board Policy 5144.1, "Students are to be recommended by the school principal for expulsion if they are found: Possessing, using, or being under the influence of any controlled substance, alcoholic beverage, or intoxicant of any kind." Students who are in violation of this policy will be suspended and recommended for expulsion. The sheriff will be notified, and the parents will be called to escort their child home. A breathalyzer may be used to test students suspected to be under the influence of alcohol.
7. Students may be checked by private security for illegal or controlled substances prior to entry to the dance area. Any student who refuses to be checked will be denied entry.
8. ANY vehicle, including limousines, can be searched. ALL PASSENGERS WILL BE HELD RESPONSIBLE AND MAY BE GIVEN CONSEQUENCES FOR ANY ILLEGAL SUBSTANCE IN THE VEHICLE.
9. All students must present their student ID at the registration table. All guests must present their high school ID or valid picture identification to be admitted to the dance. Dana Hills students not in possession of their school ID will be charged \$10 for replacement. For school dances, the ID card must be presented. Phone app barcodes do not contain photo ID to confirm user's identity.
10. Trading or selling of ticket between students is not allowed.
11. Students removed or denied entry will not be given refunds. In these cases, parents will be called.
12. Any student who is dancing inappropriately may be removed from the dance and lose privileges to attend future activities and disciplinary actions may be taken.
13. Students who violate the terms of this contract are subject to suspension from school and loss of privileges to participate in any co-curricular and extracurricular activities including athletics, senior activities, and possibly commencement exercises. The DHHS student and his/her parent are responsible for the guest's behavior. If there is a problem with a guest, the Dana Hills student will lose the privilege to bring a guest to any future Dana Hills dance.
14. We will be serving an assortment of desserts, fruits, water and soft drinks throughout the evening.
15. **No changes will be accepted to this contract.**
16. **Tickets must be purchased by closing (3:00pm) on Wednesday, October 2, 2019, in order to avoid a \$10 late fee. Tickets purchased Thursday and Friday, October 3 & 4, Will be assessed a \$10 late fee per ticket. No tickets will be sold after 3:00pm on Friday, October 4, 2019.**

THE PURCHASING STUDENT MUST HAVE A VALID ASU CARD WHEN THE PURCHASE IS MADE IN ORDER TO RECEIVE THE DISCOUNTED PRICE.
