

## 2021-2022 Fee Reduction Eligibility Form

## **Eligibility Criteria**

The following table lists annual family income, by family size, at 185% of the poverty level. If the student's family income does not exceed the amount listed in the relevant row and column, that students gualifies for an AP exam fee reduction.

## USDA Food and Nutrition Service Income Eligibility Guidelines for 2021-22

The following table lists annual family incomes by family size, at 185% of the poverty level. If the student's annual family income falls within the amount listed in the relevant row and column, that student gualifies for an AP Exam fee reduction.

These Income Eligibility Guidelines are effective from July 1, 2021, through June 30, 2022.

## Fee Reduction Instructions

- 1. Register for exams through Total Registration 9/20-11/01: www.TotalRegistration.net/AP/050729
- 2. Choose either Free/Reduced lunch or Financial Assistance when registering. **Please don't choose both.**
- 3. Fill out Fee Reduction Form and turn into the Guidance Office with a copy of your Free/Reduced Eligibility Letter from the district **OR** a copy of most recent Tax Return Form 1040 by **November 1, 2021**.

(If you do not have a copy of your letter, please call the District Office Food & Nutrition Department for a copy @ (949) 234-9509. It can be emailed to you.)

- 4. Once the Guidance Office has approved your fee reduction, log back into Total Registration and pay balance due.
- 5. Balance needs to be paid by **November 1, 2021**. If payment is not made, then the test will be cancelled and student will need to reregister with a \$40 late fee **per exam** through the Guidance Office.
